As part of Flora Food Group's commitment to transparency, we publish grievances and issues via this tracker. This tracker consists of:

- Grievance cases directed towards Flora Food Group, related to palm oil, soybean oil, coconut, or pulp & paper; and
- Priority issues with implications for Flora Food Group's supply chain, as identified through our regular monitoring activities.

Flora Food Group's Grievance Committee reviews each grievance case internally, and we further investigate each of them through our direct suppliers. Flora Food Group also collaborates with Earthworm Foundation to investigate and review each case.

We are monitoring the implementation progress closely through our direct suppliers. <b>February 2024:</b> Following engagement with our direct suppliers, we understand that NaturAceites is implementing a poverty alleviation programme, and a Continuous Improvement Programme with ProForest, amongst other programmes. They are also working with Earthworm Foundation to improve their grievance mechanism. The issue remains under review. Our suppliers confirmed there are no open complaints against Palma del Ixcán. <b>December 2023:</b> Flora Food Group is investigating the case through our direct suppliers. Our suppliers confirmed that: - Currently, there are no open environmental complaints against Naturaceites S.A. Regarding the allegations on human rights, Naturaceites has shared evidence to clarify the published allegations. - We are further investigating Industria Chiquibul and Palma del Ixcán through our direct supplier - Our suppliers confirmed that there are active engagements and verification processes with REPSA and Grupo Hame to date.
